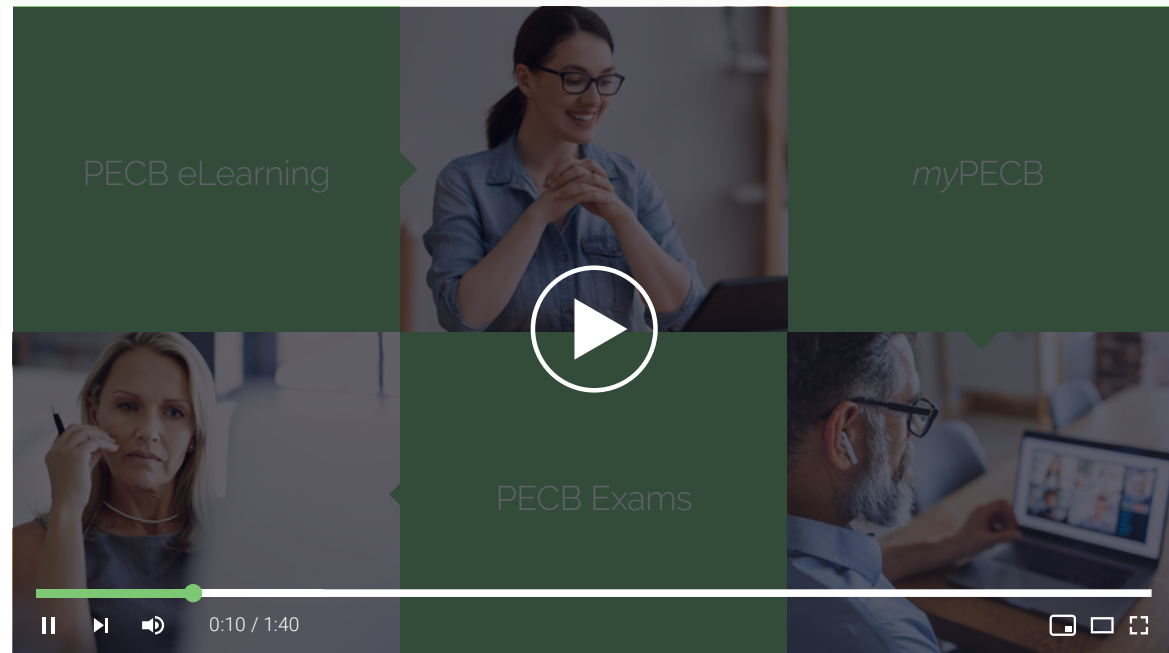
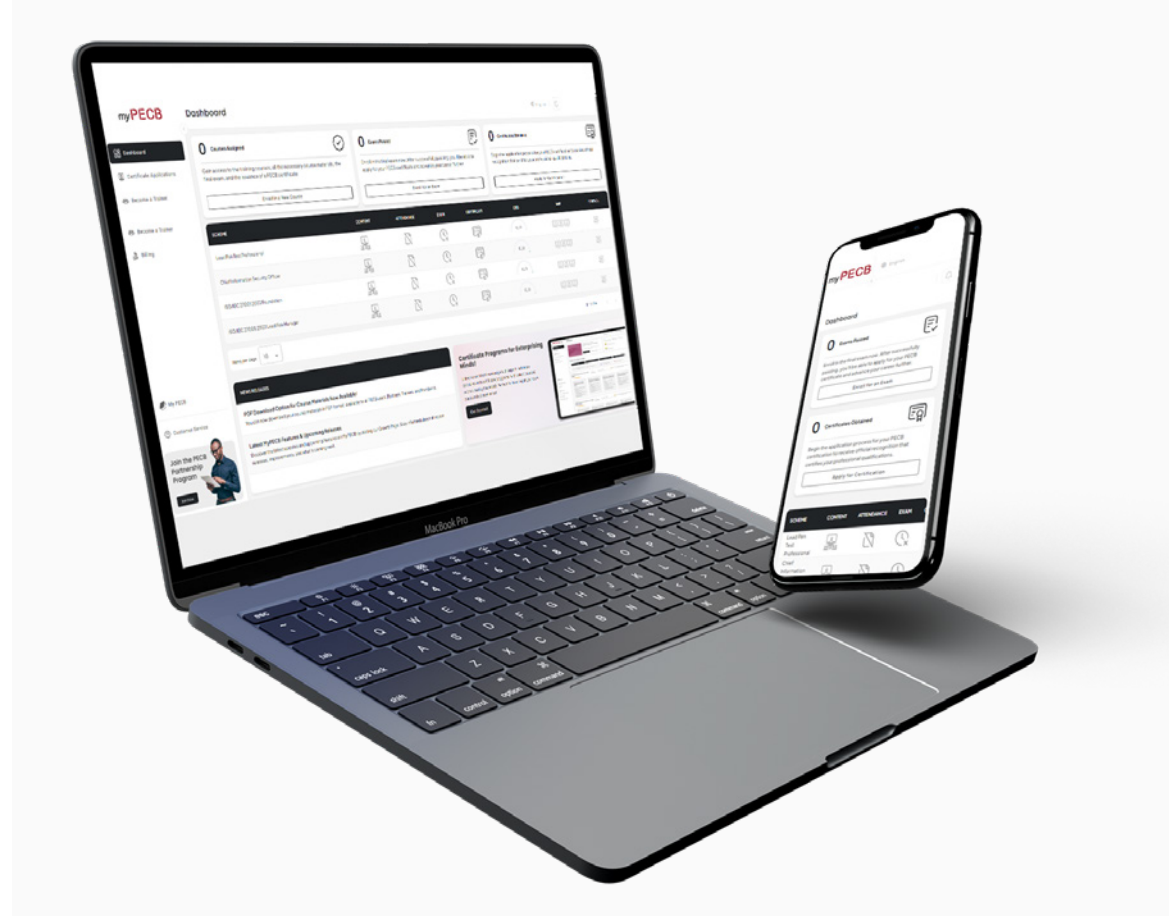
How does the ISO/IEC 27701 Foundation eLearning experience look like?

- ✓ Certification fees are included in the exam price.
