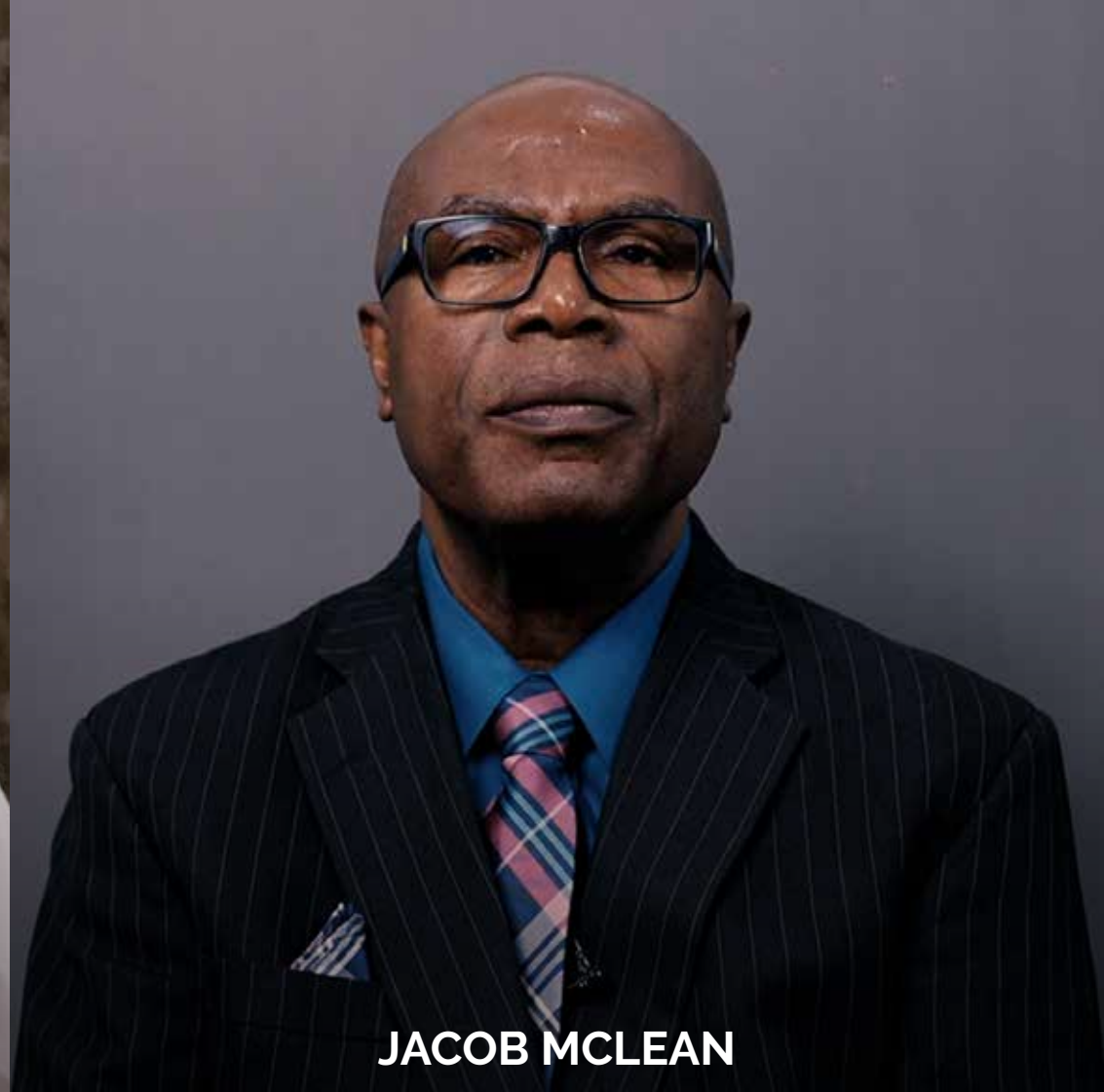

To keep our candidates engaged, we have incorporated quizzes into our eLearning training courses.

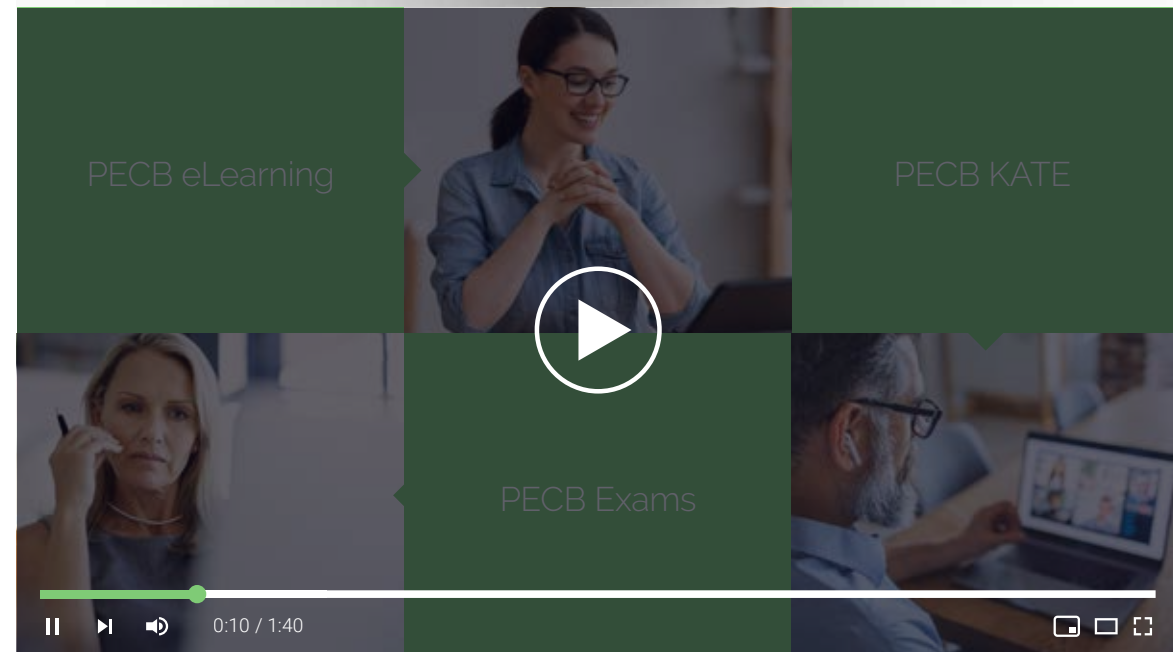
# How does the ISO 9001 Foundation eLearning experience look like?
